### Lisa's Journey A Testament to Hearth's Mission

My relationship with Hearth started in late 2023. I call it a relationship because my case manager Sophia made me feel very comfortable from our very first appointment. She and I started putting in housing applications together, and even when I couldn't make it to one of our appointments, she would come to me with an envelope full of new applications. We developed a great relationship; I could see that she really cared about my housing journey and my future.

During one of our frequent calls, she invited me to attend a luncheon at Franklin Park golf club. She then called me several more times just to make sure that I was going. Truthfully, nothing in me wanted to go, but through my struggle, I had been praying for a door to open. Something inside me said this might just be what I had been looking for, so I pulled myself together and went.

I walked in and was warmly greeted by Hearth's staff and volunteers. When I looked around and saw Hearth residents enjoying themselves, I instantly felt that this is where I was supposed to be. I sat down as Rhonda, Hearth's President & CEO, was beginning her speech, and I heard the passion, determination, and sincerity in her voice as she talked about her goal to make Hearth's programs be all they can be for the older adult population. After her speech, she walked right up to my table, sat down next to me, and introduced herself.

Over the next several hours, we discussed so much that I felt like I had known her forever.

I asked her if there was any way for me to volunteer for Hearth, as I had always enjoyed working with the older adult population and I missed feeling useful. She introduced me to Nimo, Hearth's Director of Supportive Housing, and within days she had me hosting weekly bingo games for the residents of the Four Corners building in Dorchester.

I really enjoyed seeing the residents and building friendships with them. And, after my third or fourth visit, Nimo stunned me with an offer of employment at Hearth's Ruth Cowin House that also included housing. I looked up at Nimo with tears in my eyes and thanked her for thinking of me for the opportunity and she told me, "Rhonda wouldn't stop until she could help you."

Rhonda and Hearth truly changed my life. I didn't realize how much space being homeless had taken up in my life until I saw my grandbaby playing on the floor of my new apartment, and I breathed a sigh of relief and said, "Now I'm home." When I was homeless, my shoulders were always full. Now that burden is off my shoulders, I have the room to open up and think about ways I can help others, about ways I can go further. Hearth has helped me realize that my story isn't finished yet.







### A Bold Commitment to Ending Elder Homelessness

Hearth remains a dedicated ally to older adults experiencing homelessness, providing not only housing but also critical support services that help residents maintain stability and independence. As homelessness among older adults continues to rise, Hearth is committed to expanding housing opportunities and services to meet this growing need.

### The Reality of Elder Homelessness in Boston

According to the 2024 Boston Homeless Census, the number of single adults experiencing homelessness increased by 12.9%, from 1,803 in 2023 to 2,036 in 2024. Many of these individuals are experiencing homelessness for the first time, driven by fixed incomes, rising rents, and the lack of age-appropriate affordable housing.

# Hearth Housing: A Lifeline for Older Adults

Hearth operates 228 units of permanent supportive housing and assisted living, offering older adults a place to call home with built-in support to help them remain housed. Since its inception, Hearth has housed more than 3,000 older adults, many of whom were previously homeless or at risk of losing their housing.

Despite Hearth's efforts, the demand for affordable housing continues to outpace available resources. The increasing number of older adults experiencing homelessness in Boston underscores the urgency of expanding Hearth's housing programs and advocacy efforts.

# Beyond Housing: Outreach & Prevention

Hearth's Outreach Program plays a critical role in assisting older adults who are homeless or at risk of becoming homeless. The team works directly with individuals to secure housing, provide stabilization services, and offer homelessness prevention assistance. In early 2025, The Boston Foundation awarded Hearth a two-year Safety Net Grant totaling \$50,000 to support and expand its outreach efforts, enabling more older adults in the Greater Boston area to navigate the housing system and secure stable homes. Hearth's Homelessness Prevention Program works to keep at-risk older adults housed by providing targeted financial support, such as assistance with rent or utilities to prevent eviction. However, the demand for prevention services continues to exceed available resources, making ongoing funding a priority.

### **Comprehensive Support Services**

Housing is just one part of the solution—true stability requires ongoing support. Hearth provides comprehensive care management services to help residents maintain housing, access healthcare, and navigate daily life.

To further support older adults as they age in place, Hearth is exploring new collaborations with medical professionals to enhance care coordination. A key initiative in development is a comprehensive care management program, designed to assess both new and long-term Hearth residents, ensuring they receive the full range of services needed to live safely, independently, and with dignity.

Our goal is to help residents maintain their independence for as long as possible, while ensuring they have the resources, healthcare, and community support needed to thrive in a safe and supportive environment.



#### Horace's Journey: A Safe Home Through Outreach

After retiring from a 40-year career with the City of Boston, Horace found himself in unsafe housing, surrounded by violence. "Just surviving was rough," he recalls. Determined to find stability, he turned to Hearth's Outreach Services for help.

For a time, Horace stayed at Pine Street Inn, but he longed for a place of his own where he could feel safe. Hearth's team worked tirelessly to secure him stable housing, and thanks to their efforts, he moved into Hearth's Anna Bissonnette House, where he has lived for the past six years. Now, Horace enjoys a vibrant community, engaging in Hearth's social activities—especially karaoke, his favorite.

Horace's journey is a testament to the power of Hearth's Outreach Services. By connecting vulnerable older adults to stable housing and supportive communities, we help them reclaim security, joy, and dignity. At Hearth, outreach changes lives—one home at a time.

# **Looking Ahead**

Hearth remains committed to:

- Expanding Affordable Housing Advocating for more permanent supportive housing options for older adults.
- Strengthening Outreach Efforts Increasing support for older adults who are homeless or at risk.
- Enhancing Resident Services Continuing to develop programs that support aging in place.

As the Boston 2024 Homeless Census confirms, homelessness among older adults is on the rise. Hearth is determined to meet this crisis with action, ensuring that this vulnerable population has access to stable housing and critical support services.




#### Funding


